**APPROVAL OF AGENDA FOR** MAY 19, 2022: On motion by Mr. Brown, seconded by Mr. Rogers the May 19, 2022, meeting agenda was unanimously approved.

**APPROVAL OF APRIL 14, 2022, MINUTES:** On motion by Mr. Rogers, seconded by Mr. Brown, the minutes of the April 14, 2022, meeting were unanimously approved.

### 2021 FINANCIAL AUDIT PRESENTATION: Mr. Jarrod Kilburn, CPA

Mr. Kilburn advised that there was nothing out of the ordinary and there were no significant changes for last year. "The net position of the District amounts to \$1,017,933 which is an increase of \$81,618 from last year." Capital investments went up \$33,819 due to a new camera (TV), hydro-cleaning equipment, and vehicle maintenance. Expenditures were still under budget, though, by \$73,003. On motion by Mr. Brown and seconded by Mr. Rogers, the 2021 Financial Audit was unanimously approved.

**OATH OF OFFICE FOR Mr. Brown and Mr. Rogers:** Presented and signed by the President of the Board.

**ELECTION OF OFFICERS:** Recommended by Mr. Siddens and seconded by Mr. Rogers to keep the officers as is for this year. President: Mr. Vessey; Vice President: Mr. Larsen; Secretary: Mr. Rogers; Treasurer: Mr. Brown; Director: Mr. Siddens. Approved unanimously.

## FINANCIAL STATEMENTS FOR APRIL 2022: Mr. Chuck Vessey

We are over budget this month by \$4000. Maintenance costs have doubled, or more, from last year for check valves, vacuum pumps (anything needed for the pump stations) plus high fuel costs (extra fuel used when hydro-cleaning), and the pay raise for the board members. Approved unanimously subject to audit.

### **DELINQUENT ACCOUNTS:**

Delinquent accounts over \$400 went down \$20,782. Only one account is now over \$700 and if Mrs. Vessey does not received a call from them she will turn it over to Mr. March for shut-off procedures.
