

1-2023 RESOLUTION SETTING TIMES/PLACES FOR PUBLICATION NOTICE

A RESOLUTION SETTING FORTH THE TIMES AND PLACES FOR PUBLICATION AND NOTICE OF PUBLIC MEETINGS OF THE GOVERNING BODY CONDUCTED BY THE CHERRY HILLS SANITATION DISTRICT, LARIMER COUNTY, COLORADO, AND NOTIFYING OF THE NAME OF THE CHAIRMAN OF THE BOARD, CONTACT PERSON AND TELEPHONE NUMBER AND BUSINESS ADDRESS OF THE DISTRICT

WHEREAS, the Colorado Revised Statute (C.R.S.) §24-6-402(2)(c) requires a local governing body to give full and timely notice of any public meeting; and

WHEREAS, C.R.S. §32-1-104 provides that the Cherry Hills Sanitation District (the “District”) shall notify the Board of County Commissioners, the County Assessor, the County Treasurer, the County Clerk and Recorder and the Division of Local Government of contact information for the Chairman of the Board and contact person and telephone number and business address of the District; and

WHEREAS, (C.R.S.) §24-6-402(2)(c)(II) requires a local governing body to designate a public website where notice of any public meeting is posted; and

WHEREAS, the same statute requires a local governing body to give full and timely notice of any public meeting no less than 24 hours prior to the date upon which the meeting is held.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE DISTRICT as follows:

SECTION 1: The District holds its regular meetings at 7:30 a.m. on the second Thursday of each month, at Denny’s, 420 Centro Way, Fort Collins, Colorado. As properly posted the District may hold meetings remotely or at times or places other than the designated times and place, particularly during time of emergency as declared by the Larimer County Commissioners or the Chairman of the Board or other officers of the district.

SECTION 2: The Board of Directors hereby sets forth the time and places for providing notice of public meetings pursuant to C.R.S. 24-6-402(2)(c)(II) as follows:

Time: At least 24 hours prior to any public meeting of a local governing body.
